## NEWS & ANNOUNCEMENTS

### INPEX-EMPIREPEX 2001

B N Som, Director General of India Post inaugurated national philatelic exhibition held at Indraprastha Hall, Nashik from December 22 to 26, 2001. He said that as a part of the program of promoting philately at grass root level, this national level show was being held at a district town for the first time.

The show was organized by Empire of India Philatelic Society to celebrate its 60<sup>th</sup> anniversary. After nearly three decades of India Post solely funding the shows it was in 1997 and 2000 that philatelic societies in India organized nationals on their own. This show was the first to formalize the partnership of India Post and philatelists as rightly reflected in the modified name.

Kishore Chandak of Sholapur won the Jal Cooper Memorial Award for the Best Exhibit in Championship Class for 'Early Indian Cancellations'. Anil Suri of New Delhi won the Jhunjhunwala Memorial Award for the Best Exhibit of the show for 'Fiscals of Mysore'. H S Mohamed of Chennai won the Best Exhibit in Youth Class Award for his exhibit Handstruck Stamps of GB. Dr. Kumud Kanitkar of Mumbai received the one & only 'Felicitations of the Jury' at this show, presumably for research, for exhibiting 'Reflections in Stained Glass' that won Large Silver medal.

There were a total of 4 Gold, 12 Large Vermeil, 18 Vermeil, 29 Large Silver, 42 Silver, 28 Silver Bronze, and 24 Bronze medals awarded. Vishwanath Jhunjhunwala of Kolkata topped the traditional class by winning a Gold with Special Prize for 'India Pre-independence up to East India'. Anand Shirolkar of Pune topped the Postal History class by winning a Large Vermeil with Special Prize for 'Early Indian Cancellations & Postmarks'. Prashant Pandya of Vadodara topped the Postal Stationery class by winning the Vermeil with Special Prize for 'British India Postal Stationery'. The lone exhibit in Aero-philately class by N K Agarwal of Patna won a Large Silver. Dr. Satyendra K Agarwal of Varanasi topped the thematic class by winning a Large Vermeil with Special Prize for his exhibit 'Roses'. Nidhi Mittal of New Delhi topped the Maximaphily class by winning a Vermeil for her exhibit. This is a lower award for her as this exhibit won Vermeil at Philanippon 01. Dr. Anjali Dutta of Pune was the first Runner up in the Revenue class by winning a Large Vermeil with Special Prize for her exhibit 'Fiscals of Gwalior'. The top exhibit of the class was also the top exhibit of the show belonging to Anil Suri of New Delhi titled 'Fiscals of Mysore'. In FDC class Vinay Bhanawat topped with a Large Silver medal.

Both the entries in Mophila received no award. The sole entry in Frugal received the first prize although the organizers did not appoint a Valuation Group to verify the value of the exhibit as required. The description of Frugal Philately class in the Prospectus was incomplete. In Social Philately class the prospectus missed defining the permissible percentage of philatelic and non-philatelic material in composing an exhibit.

The sole entry of picture postcards by Rajan Jayakar of Mumbai won the first prize in Social Philately Class. In one frame exhibits Prashant Pandya won the first prize for his exhibit on the Millennium. Mayur P Akole and Dr. S K Sondhi won the second prize for their exhibits 'Natural Heritage' and 'Blood – A Gift of Life'. S L Bansal of New Delhi and N K Khetan won the third prize for their exhibits 'Panda' and 'Post Independence Indian Postcards'. In Literature class Umesh Shenoy of Mumbai topped with his entry 'Olympics – Origin to Centenary'. SDS Kothari Kanya Shala of Nashik topped the Schools Collections class by winning Silver medal. 31 entries received the certificate of participation

In all 208 exhibits competed in the national show. There were 6 entries in Championship class, 24 in Traditional class, 10 in Postal History, 8 in Postal Stationery, only 1 in Aerophilately, 70 in Thematic Philately, 3 in Maximaphily, 9 in Revenues, 2 in FDC, 2 in Mophila, 1 in Frugal, 1 in Social, 29 in One Frame, 13 in Literature, 18 in Youth, 2 in School, and 3 in 'Other Class Not Covered Earlier'. The last class was not provided for in the Prospectus! The Jury put 6 entries out of competition. In addition 12 entries were absent.

D S Bhalchandra, Chief Postmaster General – Maharashtra & Goa Circle, took over as alternate Chairman of the Jury as the Chairman of the Jury, B N Som had to be away on official business after December 22<sup>nd</sup>. There was a strong rumor that Vispi Dastur was appointed as a Co-Chairman of the Jury that we have been unable to confirm. M G Pittie was the Jury Secretary.

There were 8 members of the Jury – Dhirubhai Mehta, M G Pittie, Vispi Dastur, Yogesh Kumar, Damayanti Pittie, G Madanmohan Das, Sunder Bahirwani, and Dr. S P Gupta. There were 9 Apprentice Jurors – V S Saksena, Madhu Narayanan, S Sarkar, Brahm Mehta, Prof. V K Gupta, R Binani, Rajesh Bagri, Ashok Bayanwala, and S Sahoo.

Instead of counting the shortcomings, we hope everyone involved will learn from the mistakes of this show. We will, in future shows, like to see a large number of school children visiting every day of the show, over all improvement in attendance, wide rather saturation publicity, and greater tie-up and coordination with celebrities for each and every function. All this shall be easily possible with a positive attitude and delegation of responsibilities and authority to the right candidates and calls for a change of mindset.

GRAND PRIX COLLECTION OF INDIA WITHDRAWN FROM SALE

On October 11, 2001 at the request of the Archaeological Survey of India (ASI), the London based auctioneer, 'Spink', had withdrawn first 166 lots from their sale scheduled for October 18, 2001 of 'India and States Stamps and Postal History Featuring an India Grand Prix Collection'. All these lots, valued closed to US\$ one million, formed part of the India Grand Prix Collection that belongs to Dilip Shah as per ASI records and can't be sold abroad. Under the Indian law, export of anything over 100 years old is treated as antiquity and requires the permit signed by the Director General of ASI. This permit is routinely obtained in respect of exhibits taken out for participating in exhibitions abroad but can't be granted for sale of antiquities.

Dilip Shah who had won the Grand Prix for his India collection in 1994 at Seoul, Korea displayed it last at World Stamp Exhibition at New Delhi in 1997. He was away to Geneva, Switzerland to participate in weekend festivities from October 12 to 14 organized by David Feldman for the launch of the 'Grand Prix Book' edited and compiled by David Springbett. He has returned nearly two months later only recently due to action by ASI. It is learned from reliable sources that the case has been under investigation by the Central Bureau for Investigation.

UNUSUAL POSTAL STATIONERIES

1. India Post introduced customized postal stationery, a multicolor pre-stamped envelope, on December 1, 2001 for World Computer Literacy Day. The Minister for Communications, Information Technology, and Parliamentary Affairs, Pramod Mahajan released it at New Delhi. National Institute of Information Technology, who has taken delivery of the entire print run for their use, sponsored it. It is NOT available to public or philatelists.

2. Three designs of small size and two of medium size Greeting cards were used for departmental use of India Post. In the previous, and first year of their use, these were simply overprinted "On Postal Service" and with the designation of the sender postal officer. However taking customization a step further, the matter to be overprinted was incorporated in the design and all of it was printed together. These also do not carry the denomination in the imprinted stamp area as it is no required on postal service mail. All of this makes these Greeting Cards and their Covers highly desirable although these are naturally NOT available to public or philatelists.

#### HAFNIA 01

Dhananjay Desai India's National Commissioner for HAFNIA 01 World Philatelic Exhibition decided not to visit Copenhagen after failing to obtain the permit from Archaeological Survey of India (ASI) in time and consequently Indian exhibits did not reach the show. There were a total of 8 exhibits out of which only 3 required ASI permit for having items over 100 year old. This was a direct fall out of action taken by ASI to stop the sale of Grand Prix Collection Of India that belongs to Dilip Shah as per their records. One of the three exhibits that required the ASI permit belonged to Dilip Shah. Knud Mohr the President of FIP was naturally upset and conveyed his disappointment to B N Som who has ordered an enquiry in to the case.

## PCI MEETS AT NEW DELHI

In a communication dated September 25, 2001, Dilip Shah, Secretary General of the Philatelic Congress of India (PCI), informed that "Getting quite a number of requests to postpone the PCI meeting on September 30, 2001 because of their fear of traveling due to likely American threat against Afghanistan we have been forced to postpone the regional meeting indefinitely. The new date and venue will be intimated in due course." It is reliably learnt that the efforts to postpone the meetings were on since long for other reasons and the terrorist strike on the Black Tuesday gave a handy excuse. As a senior philatelist remarked, "if you believe this (communication), you will believe anything!"

The meeting eventually took place on November 4, 2001 primarily to appoint the Jury for the forthcoming national INPEX-EMPIREPEX 2001. The failure to participate in HAFNIA 2001 was also taken up for discussion and a formal report from the National Commissioner is called for. It was decided to setup a committee to study applicability of Antiquities and Art Treasures Act to philatelic exhibits participating in the shows abroad. The committee shall have one member each from PCI, India Post, and the Archaeological Survey of India.

Next day, B N Som, Director General of India Post inaugurated the permanent office of PCI graciously provided by India Post. The office is situated in the compound of India Post H Q at Parliament Street, New Delhi. It shall go a long way in close cooperation between philatelists and the postal administrators.

B K Sinha, Secretary of PCI is in the charge of the day-to-day administration of PCI in absence of the Secretary General Dilip Shah in accordance with the provisions of PCI constitution. Dilip Shah who is also the President Elect has been incommunicado and not attending the meetings or the work pertaining to his offices at PCI. Unconfirmed reports said that he has resigned from the primary membership of PCI sometime after October 11, 2001. However Sahadva Sahoo, PCI President, confirmed that he has not received any resignation.

NOTES ON PAKISTAN – Part 34

Earlier parts were published in our issues # 18 onwards, except # 26. These are available for free download at <http://www.stampsfindia.com/Content/Download/archives.htm>

Manohar Lal, our Research Coordinator, is now working his way in to the original records of Posts & Telegraphs Department held by the National Archives of India.

In the issue # 50 we reproduced the Pakistan Posts & Telegraphs Department's Director General's Post Office Circular of 11<sup>th</sup> April 1948 and the last issue carried the first part of the Postal Notice that accompanied the above Circular. We now reproduce the second and concluding part of the Postal Notice.

POSTAL AND MONEY ORDER SERVICES TO INDIA  
Continued from the previous issue.

10. VALUE PAYABLE SERVICE – Value payable registered letters, insured letters, registered packets of printed papers and business papers newspaper prepaid with postage at newspaper

rate of postage and with registration fee may be set to be and received from India under the same conditions as have been laid down for any foreign country other than Aden.

Value payable parcels may be sent to and received from India under the following conditions:

(i) Every V P Parcel for India should be presented at the Post Office in accordance with the procedure laid-down in clause 257 B (i) of the P & T Guide, September '46 editions for such parcels to any country other than UK, Eire, Kenya, Uganda & Tanganyika territory, Malaya and Zanzibar.

(ii) A posting fee of 2 annas must also be prepaid by the sender by affixing postage stamps for the value of the fee to the article itself.

(iii) The amount to be recovered from the addressee of a V P Parcel from India will be the sum specified by the sender for remittance to a money order of the same amount to India plus a delivery fee of four annas.

In other respects the rules laid down in clauses 257-B, 257-C, 257-D, 257-E of the P & T Guide, 1946 edition will generally apply.

11. REPLY COUPONS – International Reply Coupons may be exchanged between Pakistan and India under the normal conditions.

12. MONEY ORDERS – Money Orders for India will be made out by the remitters on the inland money order forms, the amount being expressed in India rupee. The maximum amount for which a single money order can be issued will be Rs. 600/-. No money order to contain a fractional part of an anna.

They will be treated in the same manner and be subject to the same conditions as money orders for Burma, the rate of commission being as laid down in clause 293-A (i) of the P & T Guide, September, 1948 edition. The remitter are advised to show in the address of the payee the Indian Province in which the office of payment is situated.

The remitter will be entitled to obtain free of charge or acknowledgement of payment of the amount of the order signed by the payee.

Airmail and Telegraphic money orders may also be sent to India under the same conditions as apply to such money orders for Burma, the charges being:

For the Air Mail Money Order – Money order commission at the rate applicable to surface money orders plus an airmail fee at 2 1/2 annas per money order irrespective of the amount of that order.  
For the Telegraphic Money Order – Money order commission at the rate applicable to surface money orders plus usual telegraphic change at ordinary or express rate as the case may be plus a supplementary charge of two annas.

13. POSTAL ORDERS – Indian Postal Orders issued in India after the 31<sup>st</sup> March 1948 shall not be payable in Pakistan. Similarly Pakistan Postal Orders issued after the 31<sup>st</sup> March 1948 shall not be payable in India. Postal orders of one dominion issued before or on the 31<sup>st</sup> March 1948 will, however, be payable in the other Dominion up to and including the 30<sup>th</sup> September 1948 under the usual conditions.

14. PAKISTAN OFFICES OF EXCHANGE WILL BE –

For letter mail (until further orders) – Karachi, Lahore, Dacca, Poradah and Jessore

For Parcels, V P Articles, Ordinary Money Orders, Air Mail Money Orders – Karachi, Lahore and Dacca

For Telegraphic Money Orders – Frontier Telegraphic offices will be Karachi CTO, Lahore CTO and Dacca CTO

Advance copy forwarded to –

(i) All heads of circles for information and issue of necessary instructions to all concerned.

(ii) The Superintendent Foreign Post Karachi, Postmasters Lahore, Dacca, Poradah and Jessore for information and guidance.

(iii) All head Post offices and important sub-offices for information and guidance.

2. \*\* Copies of the draft bilateral agreement for the exchange of money orders and value-payable articles with India with effect from the 1<sup>st</sup> April 1948 are enclosed. It should be clearly understood that the provisions contained therein are merely tentative and are subject to approval by both the governments. In order, however that the work in the office of exchange should go on, it should be assumed that the provisions of the enclosed draft agreements will be approved and work should, therefore, be strictly regulated on the basis thereof.

\*\* A memorandum of instructions to be followed by the Pakistan Offices of exchange in dealing with mails for and from India with effect from the 1<sup>st</sup> April 1948 is also enclosed and should be carefully studied and explained to the staff.

3. Copy also forwarded to – (i) All the Ministries of the Government of Pakistan, (ii) Cabinet Secretariat, (iii) Constituent Assembly, (iv) Auditor General of Pakistan, (v)\* The Accountant General, West Punjab, Lahore, (vi)\*\* The Accountant General, East Bengal, Dacca, (vii) The Principal Information officer, for favor of issue of a Press Note on the subject, (viii) The Director General of Posts and Telegraphs, New Delhi.
