##### NEW ISSUE UPDATE

India Post's next stamp issue is scheduled for release on February 5, 2003 to mark 'Aero India 2003' that is a biennial international aerospace exhibition organized jointly by Hindustan Aeronautics Limited and the Ministry of Defense at Bangalore. The issue consists of 4 stamps, 3 in the denomination of Rs. 5 and 1 in the denomination of Rs. 15. A Miniature Sheet shall also be issued.

The issues along with the First Day Cover and the information sheet, at Rs. 2 each, shall be available on sale at nearly 1000 selected Post Offices including all Philatelic Bureaus and Counters.

The suit filed by Rajesh Varma against PCI and others came up for hearing on January 20, 2003. Some of the defendants filed their written statements and the next date was fixed for February 14, 2003.

MANGALAPEX

Speakers at the inauguration of the three-day "Mangalapex 2003" at Mangalore on January 15, 2003 stressed the need for individuals, young and old alike, to pursue creative hobbies. They expressed concern that hobbies such as philately and numismatics were declining with the advent of new-age entertainment.

Inaugurating the event, the Chairman of the Karnataka Bank Ltd., Ananthakrishna, said the joy of a hobby had to be experienced to be believed. Such exhibitions helped rekindle people's interest in hobbies and provided a diversion from the daily grind. Noting that the present means of "diversion" was television, he said it was not a healthy trend. Other avenues of diverting one's mind through cultural and spiritual means and hobbies provided the necessary creative outlet to people.

The Chairman of the Lamina Group of Companies, N Vinay Hegde, who released the souvenir, said philately was more than a hobby. It enlarged one's mind and provided information on various facets of life. Noting that the culture beamed down into our living rooms was alien to the Indian cultural ethos, he said it was imperative for all concerned to show a sense of understanding on this vital issue.

The Chief Postmaster General, Karnataka Circle, K B H Nair, who released a special cover on Rani Abbakka, said the department planned to popularize philately at the village level. Special covers were a unique way of shedding light on forgotten aspects of the history of any area and a means to honor personalities.

The General Manager of the Dakshina Kannada Telecom District, K J Chacko, who was the chief guest, said people had forgotten the art of writing letters with the advent of technology. This had taken the spotlight away from philately as a hobby. He lauded the conviction shown by his sister department in keeping a tradition alive by conducting such informative exhibitions.

The Director, Postal Services, South Karnataka Region, Charles Lobo, who presided over the function, noted that Mangalore was the first division to organize a divisional-level exhibition. He said 280 philatelic frames had been displayed at the exhibition, including 76 frames for invitees, 95 frames for senior groups, 65 for juniors, and 40 for Nehru Philately clubs. He pointed that the exhibition was a festival of stamps, and added that these small pieces of paper were the true ambassadors of any nation.

The parish priest of St. Sebastian's Church, Bendore, J P Tauro, blessed the occasion. The Senior Superintendent of Post Offices and Chairman of Mangalapex 2003, M A Naik, welcomed the gathering. K Babu

Naik, Vice-Chairman of Mangalapex 2003, proposed a vote of thanks. M K Krishnayya, President of the Dakshina Kannada Philatelic Association, and K S Shetty, Secretary of Mangalapex, were also present on the occasion.

COPS ABSCONDED WITH STAMP SCAM KINGPIN

The Mumbai police suspended four policemen on January 15, 2003 who allowed Abdul Karim Telgi, mastermind in the multi-billion countrywide fake stamp scam, to stay in his lavish Cuffe Parade home while he was supposed to be in police custody. Authorities had earlier sealed the ground floor flat at Meena Manor in November 2002.

Assistant Inspector B P Kamat, Sub-Inspector G M Dewade, constables P T Pise and M K Borude, all from Mumbai Crime Branch (Unit V), had been dispatched to Karnataka last week to bring Telgi to Mumbai. They were not heard from since.

Meanwhile, Deputy Inspector General Subodh Jaiswal received news that Telgi was at his Cuffe Parade home. Jaiswal notified Mumbai Police Commissioner R S Sharma, who sent another police team to Telgi's home. There they found Telgi and the four policemen. He was escorted back to the lock-up in the evening.

Apparently, after reaching Mumbai, instead of taking Telgi to the Crime Branch office, the four policemen took him straight to his sealed house at Cuffe Parade. Since then, Telgi led a lavish life there.

Mumbai Commissioner of Police Sharma said that an inquiry has been initiated against the four policemen. Deputy Commissioner of police (crime) Pradip Sawant is expected to submit a report in the next three weeks.

PHILATELY IN TRANSITION IN INDIA, Part 41

AUCTION HEAT ON STAMP COLLECTOR by Dalip Singh

Stamp collector Dilip P Shah was booked by the Central Bureau of Investigation for auctioning a rare collection of antiques in England in 2001. Now, the bureau will send letters rogatory to Britain and America to verify Shah's claim that the stamp collection belonged to his NRI brother who had listed it at Spink and Son for auction.

Shah, the winner of PhilaKorea 94, a showcase event for stamp collectors, was booked under the Antiquities and Art Treasures Act, 1972.

Now, the CBI is sending a letter rogatory to Britain to ascertain that the stamps owned by Shah are those shown in photocopies and an auction catalogue seized by the bureau during a search of Shah's Jabalpur residence. It also seeks to find out how Spink and Son got the stamps.

Another letter rogatory - to the US - is being sent to find out if the stamps actually belong to Dilip Shah's Atlanta-based brother Dhiraj.

CBI sources said the draft report of the letters rogatory was sent to the Union home ministry for clearance more than a week ago. Once cleared by the ministry, the report would go to the Union law ministry for vetting, after which a local court would dispatch the letters rogatory to Britain and America.

Shah, who has collections of rare stamps, wanted to exhibit them at the grand prix in Seoul in 1994. In the export permit he obtained from the Archaeological Survey of India, he declared that the stamps belonged to him.

He got the permit, displayed 540 stamps at PhilaKorea and won the grand prix. He returned with all the stamps.

Shah, who was the general secretary of Philatelic Congress, a private association of stamp collectors, also participated in a Singapore competition the next year and returned with all the stamps.

The CBI said Shah decided to auction more than 160 antique stamps at Spink and Son in October 2001.

Shah said he decided to sell them to get his finances in order before retiring.

However, the auction could not take place as the Indian High Commission in London objected to it, the CBI sources said.

Shah says, as the stamps were owned by a member of the family, he did not realise it was essential to specify – at the time of obtaining the permit to display the stamps at Seoul and Singapore – that the stamps were actually owned by his brother and not him.

Shah's collections are believed to be one of the finest, some of them depicting a human head and Queen Victoria and East India Company emblems. One of the stamps is pasted on an envelope addressed to the "Maharani of Cossipore" in West Bengal. The prices of the stamps, which included 2 anna and 4 anna ones, at the aborted auction ranged from £200-18,000.

CBI sources said people continue to export antique stamps for hefty sums. A senior CBI officer said stamp collectors should be aware of the Antiquities and Art Treasures Act to avoid coming under the police scanner.

THAILAND'S SCENTED STAMPS FOR VALENTINE'S DAY

The Communications Authority of Thailand (CAT) will launch its popular rose aroma stamps at post offices nationwide on February 1, marking the second straight year the kingdom has issued the stamps after a successful debut in 2002.

"We hope the public uses this stamp for Valentine's Day," a CAT official said. Four million stamps are being printed in two designs and will be available for four Baht (about 9.3 US cents) each, she said.

One stamp depicts the roses in the shape of a heart while the other shows a bear holding a rose bouquet. This year's aroma stamps feature the unusual Blue Nile Rose, a lavender-colored, sweet fragrance blossom.
