##### MIZOPEX

The First ever Philatelic Exhibition in Mizoram was held in Aizawl on January 21-23, 2003. There were thirteen participants plus two schools. Well known artist and philatelic journalist, Dipok Dey of Kolkata was one of the Jury at the show.

In commemoration of the exhibition they have released three special covers one on Cheraw, the most colorful Mizo Dance form, second on the hillock where Thasiama's Mithun/Gayal gave birth and the third on the Traditional Mizo Woman's handloom.

The Logo was the portrait of a young girl attired in traditional costume and headgear. It is the first time that any exhibition in the world has adopted a living logo. Her name is Zonunmawii and on the inaugural day she wore the same dress, as featured on the logo and welcomed the Governor and the visitors to the exhibition. #### MAPPEX

The Governor of Madhya Pradesh, Dr. Bhai Mahaveer inaugurated the 10<sup>th</sup> Madhya Pradesh Circle philatelic exhibition on January 28, 2003 at Bhopal.

There were 62 exhibits, including 29 in the youth classes, in about 150 frames. The majority of the exhibits were in the Thematic Class, which is in conformity with the trend that is prevailing in India. However small number of entries in the youth class points to the direction where more work is required.

S B Jain, former member of the Postal Services Board, gave the awards away on the concluding day, January 30, 2003.

The Jury consisted of the Chief Post Master General of Madhya Pradesh Circle, Manu Vyas (Chairman), Kaveri Banerjee, Post Master General of Indore Region (Co-Chairperson), Sahadeva Sahoo, President of Philatelic Congress of India, Dr. S P Gupta, P K Bisoi, Director of Postal Services at Bhubaneswar (Apprentice) and Anurag Priyadarshee, Director of Postal Services at Ahmedabad (Apprentice). However Dr. S P Gupta, being sick, and P K Bisoi, being under transfer, were unable to make it to Bhopal.

There were 3 Vermeil, 3 Large Silver, 7 Silver, 5 Silver bronze, 11 bronze, 22 Diplomas awarded by the Jury. Om Prakash Kedia of Indore won the Chief Minister's Trophy for his exhibit "English Cricket" and Anees Akhtar Siddiqui of Bhopal won the Chief Postmaster General's Trophy for his exhibit "Bhopal". Both these exhibits also won Vermeil medal. Dheerendra Singh Chouhan won the remaining Vermeil for his exhibit "Mahatma Gandhi". Padmakar V Pandharkar of Indore for "Barwani Fiscals", D N Ramesh of Gwalior for "Mushrooms", and Alok Kumar Bihani of Indore for "World of Cricket" won Large silver medals. The best youth exhibit "Big cats" of Monis Kidwai of Bhopal won 'Man Singh Nahar' Trophy.

PHILATELIC DISPLAY AT FATEHNAGAR

Mithoo Lal Bansal, the President of Bhilwara Philatelic Club, displayed his collection of stamps, coins & currency notes on invitation at a special exhibition organized as a part of inauguration of new building of Maharishi Dayanand Uchchh Prathmik School at Fatehnagar, Rajaasthan on January 14, 2003.

NEW WEB SITE

The official web site of India Post's Philatelic Bureau at Ernakulam in Kerala Circle, <http://www.philakochi.com> was recently launched. The visitors to the site can view and order the new issues and products on line. The standing order deposit account holders of the bureau enjoy the privilege of getting a free home page besides having access to their accounts online. The site also provides the facility of opening the accounts with the bureau online.

POST OFFICES TO SELL PRE-PAID PHONE CARDS

The Postal Department would soon sign a memorandum of understanding with cell phone companies for selling pre-paid cards, Tamil Nadu chief post-master general Dr U Srinivasa Raghavan said on January 20, 2003 at Tiruchirapalli. He told reporters that Bharti Airtel, a cellular service provider, was being provided e-billing facility by the post offices at 38 places through computers. Similar facilities would be extended to other cell phone companies also, he said.

The department would also ensure that Speed Post articles were delivered the very next day through all the post offices located in the circle. He said the department would soon sign an agreement with the railways for a hybrid system that would help it deliver the Speed Post articles to the addressee the next day itself. It would also utilize vehicles, now being used in cities, for transporting Speed Post articles to various destinations. The new Speed Post delivery system would be launched before February 15, he said. Special attention would be paid to industrial areas like Hosur, Maraimalainagar and Irungattukottai to book and deliver the Speed Post articles. The booking time would be extended and the delivery system would be made more efficient and prompt, he said.

He said a permanent philatelic exhibition would be set at Chennai and Tiruchirapalli.

Various associations during the last 2 years have circulated warnings of Collamer and the Collamer Foundation, both of Phoenix Arizona. "These have stated that he is still trying it on so be warned, do not consider sending material until the payment from any transactions are firmly in your bank account."

We have carried reports of cases where he cheated two stamps dealers and tried to cheat another in India, in issues # 83, 84, and 86

PHILATELY IN TRANSITION IN INDIA, Part 42

MAPPEX 2003 was a reminder of what has been constantly in focus in many of the previous newsletters - reforms are the need of the hour, philately in India needs Transparency, Glasnost, and perestroika.

The appointment of the Jury is done from the list of accredited jurors submitted by the Philatelic Congress of India (PCI) to the Philatelic Division of the India Post. It is no secret that PCI has never considered a large number of qualified persons for the job while giving preferential treatments at every step to certain individuals.

This list has jurors in three categories, international, national, and state/circle. India Post and PCI appoint international and national jurors jointly while the state/circle exhibitions request the postal directorate for appointments. It is also well known in the philatelic community that several jurors lobby for and get assignments repeatedly while others don't get any.

Another undesirable activity that must immediately be stopped is the appointment of international and national jurors for state/circle level exhibitions. It is against natural justice since state/circle level jurors cannot go as jurors to national, and national level jurors cannot go as jurors to international exhibitions. Sahadeva Sahoo and Dr. S P Gupta - the philatelist members of jury at MAPPEX, both are national level jurors.

We believe it is the job of the leading philatelists to guide India Post on philatelic matters. Even if India Post makes an incorrect appointment it must be pointed out to them. And such appointees themselves must politely decline to accept such appointments.

It is not only free travel, boarding, lodging, and the prestige of the appointment but also the opportunity to exercise the influence that can be exerted over exhibitors and fellow collectors primarily to sell philatelic material at inflated prices and to procure philatelic material for free or nominal value that attracts the jurors.

Manu Vyas, Sahoo, and Bisoi were exactly in the same positions at Orissa Circle Philatelic Exhibition, ORPEX in April 2002 at Bhubaneswar that generated lots of controversies. The points raised by a concerned exhibitor, Shakil Ahmed, are still not settled. Vyas may not have had any ulterior motives but nonetheless his image suffers due to his reliance in philatelic matters exclusively on people such as Sahoo.

Dilip Shah, a resident of Madhya Pradesh, also attended the exhibition on the first day in an undefined role. He however was seen finalizing medals with Sahoo in what capacity only he and the organizers might be aware.

Not surprisingly this exhibition attracted its share of grievances from the collectors on jury decision-making including the best exhibit award.

The jury - exhibitor relations can improve once there is conformity on application of the regulations for evaluation of the exhibits between the jury and the exhibitor in place of ambiguity and personal preferences of the jury.

This is the name coined as acronym for 'Indian National Philatelic Exhibition' by the Department of Post for the national exhibitions organized by them since 1970. In fact that it exactly what has happened with this exhibition, as many collectors are under the impression that it is a Departmental Exhibition. GREG MANNING AND AUCTIONEER SIGN AGREEMENT

Greg Manning Auctions, Inc. (GMAI) is a global collectibles auctioneer and merchant, with both Internet and live auctions and operations in North America and Asia. In North America, GMAI is a leading traditional and electronic -- Internet, interactive telephone, and Internet and live simulcast -- auctioneer and merchant/dealer of collectibles. Coins, stamps, sports cards, and affordable fine art are offered at <http://www.gregmanning.com/> and <http://www.teletrade.com/>.

Greg Manning, CEO and President of Greg Manning Auctions, Inc. (GMAI) announced on January 23, 2003 that GMAI and Auctentia, S.L., a wholly owned subsidiary of Afinsa Bienes Tangibles, S.A., have signed a definitive agreement for the acquisition by GMAI of Auctentia Subastas, S.L. of Spain, a majority interest in Corinphila Auktionen AG of Switzerland, and the Kohler group of auction companies of Germany. In addition, in two separate transactions, GMAI has agreed to acquire from Auctentia an inventory of stamps valued at approximately \$10,150,000 and fine art valued at approximately \$1,250,000, and has approved a \$5,000,000 sale of GMAI stock to Auctentia. GMAI will issue an aggregate of 13 million shares of GMAI in payment for the various companies, cash and inventory to be acquired in these transactions. The issuance of shares by GMAI is subject to shareholder approval, as well as other customary conditions.

Currently Auctentia holds approximately 43% of GMAI's outstanding shares. Esteban Perez, Chairman of Auctentia, stated, "This transaction creates a truly global collectibles company, featuring the merger of the finest stamp auction houses in the world, as well as the premier rare coin wholesaler in the United States." He continued, "The excellent reputation of all of our individual companies, combined with the strong management teams in each one, create a true auction network through which our consignors can sell to their advantage in Europe or America in a truly seamless fashion."

Greg Manning stated, "The bringing together of these great companies, who are the leaders in Germany, Spain and Switzerland, with our strong auction and rare coin businesses in the United States, marks the beginning of a new era in philately and numismatics." He continued, "We will continue to build our company in Asia and Latin America, with our first major philatelic auction in Hong Kong scheduled for April. We will



have greatly added to our overall purchasing power through these transactions, and we will aggressively pursue the top collections that come on the market."

Shareholders holding approximately 60% of the outstanding shares of GMAI have agreed, subject to certain conditions, to vote in favor of these transactions. The closing of each of these transactions, which is not conditioned upon the closing of the others, is expected to occur shortly after all necessary approvals are obtained.
