The Defendant society prayed that as the affidavit by way of evidence on behalf of the defendant by PCI Vice President Y Kumar signed on August 22, 2003 at Bareilly has not been printed out properly, hence should be allowed another date to file the same. The next date for hearing is now fixed for September 9, 2003 when Kumar will be cross examined. The suit filed by Rajesh Varma against PCI and others came up for hearing on July 9, 2003 and August 16, 2003. The next date for hearing is now fixed for September 5, 2003 for arguments. ## FAKE STAMP SCAM UPDATES

Dattatreya Yashvant Dal, a senior police inspector attached to the crime branch of Mumbai police, was arrested on August 20, 2003 by the Special Investigation Team (SIT) investigating the counterfeit stamp and stamp paper case for alleged involvement in abetting to the racket. This is the 50th arrest in the case.

Dal was remanded to the SIT custody till September 1, 203 when a team led by Superintendent of Police C H Wakade produced him in the court of Judicial Magistrate (First Class) M N Bondre at Pune. A report seeking Dal's custody for 30 days was also submitted.

Posted at the Mumbai police crime branch unit at Dharavi, Dal was the superior officer of Assistant Inspector Dilip Kamat who has already been remanded to judicial custody.

According to SIT officials, Dal is alleged to have made deliberate efforts to shield the alleged ringleader Abdul Karim Telgi while he was in police custody. Telgi was found allegedly entertaining some officers and constables of Mumbai Police crime branch at his Cuff Parade flat while in the custody of crime branch in January this year.

SIT sleuths alleged that despite recovery of counterfeit stamps and stamp papers estimated to be worth Rs 850 crore by the Mumbai police crime branch, the officials did not arrest Telgi in the case. (Telgi was then in police custody in a murder case). Telgi had been allegedly taken to Goa illegally while he was in the custody of the crime branch.

Arguing for the custody of Dal, Special Public Prosecutor Raja Thakare conceded SIT officials had recorded his statement before the arrest. He alleged that Dal had tried to mislead the investigators. Thakare also accused Dal of fabricating records of Mumbai police crime branch and alleged he (Dal) had received money from Telgi.

Pointing out that Dal's statement has already been recorded, defence lawyer Viraj Kakade argued that the SIT did not have adequate reasons to seek his prolonged custody. He prayed that Dal be remanded to police custody for a short time.

The SIT also produced Bangalore-based lawyer Abdul Rashid Sikandarsahab Kulkarni in the same court along with a report seeking extension of his custody. The magistrate remanded Kulkarni to judicial custody. Meanwhile, Special Judge S M Shembole adjourned hearing on an application by the SIT seeking custody for four of the accused who had been arrested during the initial stage of investigations. The application had been moved on August 21, 2003 and the judge has asked the defence lawyers to file their say. The application is scheduled to come up for hearing on August 25, 2003.

## NEW COMMEMORATIVE COINS

The Deputy Prime Minister of India, Lal Krishna Advani, released a set of commemorative coins on Durgadass Rathore, on August 25, 2003 at a function held at New Delhi. The Vice President of India, Bhairon Singh Shekhawat, presided over the function.

INTERNATIONAL CONFERENCE ON ILLEGAL ISSUES World Association for the Development of Philately (WADP) is organizing, together with WADP partners and the Portugese Post Office in Lisbon, Portugal an International Conference on Illegal Issues, on 25 September 2003. This will be followed on 26 September 2003 by the fifth General Assembly of the WADP.

WADP's goal is to reach a strong consensus in the battle against illegal issues at the outcome of these two world philatelic meetings. In preparation for these meetings, WADP is putting together an exhibition which can show the extent of the proliferation of illegal stamps.

WADP appeals for receiving a copy of a maximum number of advertisement sheets and publications that publicize illegal stamps or others that may be considered of a doubtful nature for inclusion in the exhibition.
