Coins are in two denominations of Hundred Rupees and Two Rupees:

Hundred Rupees Coin is Circular in shape (44 mm dia), weighs 35 gms and is made of Quaternary Alloy (50% silver, 40% copper, 5% Zinc, and 5% Nickel). Two Rupees Coin is of Cupro Nickel Alloy (75% copper and 25% Nickel), Eleven sided 26 mm size from flat to crest weighing 6 gms. Proof Coins set are priced at Rs 850 whereas un-circulated coins available for Rs 450. In addition, a sales tax/surcharge of 11.5% is also payable. Postage, insurance, packing charges are Rs 130, 200, 250, 330, 400 for one, two, three, four and five sets respectively. Coins can be booked by submitting a Demand Draft drawn on Kolkata branch of any Nationalized Bank in favor of 'Reserve Bank of India - A/C India Government Mint, Kolkata'

FAKE STAMP SCAM UPDATES

Former Andhra Pradesh minister and an accused in the stamp scam, C Krishna Yadav, now in a jail in Pune, will contest the assembly polls as an independent from Hyderabad's Himayatnagar constituency that he had represented in the dissolved assembly. His wife Nalini and mother Kamalamma filed his nomination papers on March 31, 2004.

With the arrest of three persons, the Delhi's northwest district police on March 31, 2004 claimed to have seized fake stamp papers and bank drafts worth over Rs 5.5 million. The police said one of the accused, Hans Raj Vats, is a property dealer in Sultanpuri. "He was selling stamp papers at half the market price. We used a decoy customer to strike a deal with him and then arrested him," stated Deputy Commissioner of Police (northwest) Sanjay Singh. On interrogation, Vats reportedly broke down and revealed the involvement of his associates, Ashok Aggarwal and Ashok Goyal. Several fake demand drafts of Bank of India were also seized from the accused. "Vats is the kingpin of this racket. He also used these stamp papers for executing property deals," added Singh.

After questioning two senior officers of Delhi Police, the Central Bureau of Investigation (CBI) on March 23, 2004 questioned inspector Krishan Kumar, station house officer (SHO) of Rohini area, in the multibillion fake stamp scam. On March 19 and 22, 2004 DCP (legal department) R S Ghumman was also called by the CBI. Ghumman was the additional deputy commissioner of police of south district when the case against Telgi was registered.

After taking over all cases of fake stamps in the country on orders of the Supreme Court, the CBI has set up a special cell to initiate probe into the fake stamp paper scam. The cell is likely to operate from Mumbai and will be led by Joint Director (Economic Offences) Archana Ramsundaram. CBI director U K Mishra said the agency has constituted 48 special teams to probe into as many cases across India.

KALPANA CHAWLA AUTOGRAPHED PHOTO FOR \$125,000 Regency-Superior will conduct a major Public Stamp and Space Auction on Saturday, April 17th at their galleries in Beverly Hills, California. Over 2,000 lots will be offered including USA, British & Worldwide singles, covers and country collections, as well as Space Collectibles and Space autographs.

This sale includes an incredible collection of crew signed items from the ill-fated STS-107 Columbia Shuttle that broke up in the earth's atmosphere on February 1, 2003. This lot contains seven separate items each signed by the complete crew. One item is a beautiful 8"x10" NASA color photo of the crew in pristine condition, and signed by each member.

At least seven such photos have appeared for sale on eBay, all of which have been shown to be autopens. Each of the seven items is guaranteed authentic. The remaining six signed items in this lot include a vehicle pass, a color flier produced by Boeing, a briefing booklet, an 8½"x11" cover sheet of their post-test briefing, a #6 envelope cancelled with the launch date (only known signed cover by this crew), and an 8"x10" glossy of the Mission Crew Patch Logo with emblem. Before the mission, the crew was not together as frequently as most crews because of the security concerns related to Payload Specialist Ilan Ramon's Israeli citizenship, so opportunities for the crewmembers to sign as a group were very limited. The entire auction is available online for viewing and bidding, and includes full lot descriptions, estimates, color photographs and opening bids. Following is the complete text of lot's description from the catalog that is estimated at \$125,000:

## 2003 THE ULTIMATE SHUTTLE AUTOGRAPH COLLECTION

On January 13, 2003 at 10:39 AM Eastern Standard Time, the Shuttle Columbia was launched from the Cape with six American and one Israeli astronaut aboard. At 8:00 AM on February 1, 2003 communication was lost with the shuttle as it broke up in the earth's atmosphere over Texas and Louisiana. The crewmembers: Commander: Rick D. Husband; Pilot: William C. McCool; Mission Specialists: Michael P. Anderson, Kalpana Chawla, David Brown and Laurel Blair; Payload Specialist: Ilan Ramon were all lost in the tragic accident. Before the mission, the crew was not together as frequently as most crews because of security concerns related to Payload Specialist Ilan Ramon's Israeli citizenship, so opportunities for the crewmembers to sign as a group were very limited. Fewer crew signed items and no opportunity to sign after the flight itself make an item signed by the entire crew an extreme rarity. This lot contains SEVEN SEPARATE ITEMS, EACH SIGNED BY THE COMPLETE CREW! We have never before had the opportunity to offer a holding such as this. Each of the seven crew members have signed all seven of these items for a total of 49 signatures of the late crew. ITEM #1: An Official, color 8"x10" glossy of the Mission Crew Patch Logo with the "Microgravity" emblem in the center. A central focus of this mission was microgravity research. Each of the crew has signed next to his/her name surrounding the shuttle-shaped logo. ITEM #2: A standard #6 white envelope cancelled on the launch date of January 16, 2003 with the STS-107 mission logo used as the cachet. All seven crewmembers have signed next to the logo. This is the only cover we are aware of that was signed by the entire crew of STS-107. ITEM #3: An official 8"x10" NASA color photo (on Kodak Professional Paper). As noted above, very few of these photos exist. It has been noted that at least seven such photos have appeared "eBay" since the tragic events of February 1, 2003; all have been shown to be autopens and not genuine signatures. These are guaranteed genuine. A similar photo brought about \$14,000 in a November 2003 auction. That photo had some bends and creases; this one is pristine. ITEM #4: This item is a post-test briefing produced by 'United Space Alliance' with the 8.5"x11" cover sheet being a red, white & blue image of the Orbiter / SCA Mate - MDD (STS-107A-OV-102). All seven signatures are at the top, three in black, and four in blue ink. Probably unique. ITEM #5: An original 8.5"x11" vehicle pass in the standard neon orange color for the OV-102, Palmdale Plant 42, Site #1. This is pass No. 046 and has a printed shuttle logo at the right with a simulated signature of the CLS Security Mgr. at the lower right. An extremely eye-catching and impressive item. Another probably unique piece signed by all seven astronauts. ITEM #6: An original Boeing 8.5"x11" color flier welcoming the STS-107 astronaut crew to their Palmdale facility on February 16, 2001, almost two full years before their loss. All seven autographs are present, Ilan Ramon's is a bit smeared, but still clear due to the glossy finish of the piece. ITEM #7: STS-107 Flight 28, Flight Crew Briefing booklet signed at the right next to the printed names of each of the crew members. These briefings were not readily available to the public. Another item that is likely to be unique. As anyone can see, this is an extraordinary group, collected by an individual who worked closely with the crew and with the space program. The consignor wishes

the entire group to sell as a single unit; he feels it is a wonderful memorial to the seven brave astronauts who gave their lives in furthering the aspirations of mankind. As a further "bonus" the consignor indicates that he would be happy to discuss with the successful buyer the manner in which these items were acquired and signed in his presence. He will also take the successful bidder on a personal tour of the Cape (assuming you can get there) with the insights of a true insider to share. (Security clearance will be required).
