ILYAS PATEL, Ahmedabad (Editor, GPA News, Gujarat Philatelists Association)

You have opened a very healthy debate on Inpex 2008 awards and I personally feel that it is very important for the benefit of future generations.

Regarding the awards I have also written a strong editorial in GPA News letter which in expected to be in circulation shortly. It was a very nasty affair and I personally feel that all awards above Large Slver were pre-conceived and prefixed. This was confirmed in the open critic session the way the members of the jury hiding their face to reply on stage. Their body language was also confirming their guilty conscious.

The only answer that gave was "come tomorrow and we will reply you at your frames". If this was the answer what is the meaning of open critic session, a joke tossed on participants or a false play they were playing on the dais?

It was a misfortune on my part that on that D-day by coincidence I was sitting just few feet (hardly 6-7ft) from my frames and I saw a jury member come to my frames and started judging. To my great surprise he finished judging my entire eight frames in only one minute. I immediately concluded that it's all over.

I informed this incident to you when I requested you provide the guidance there only. It is hard to believe that the member of jury is so intelligent that he can judge a highly technical subject covering as many as 49 topics associated with my theme BRIDGES.

The next day when I contacted the jury member he personally came with me and started giving me his opinion. The first explanation he gave to me was "Patel, I have downgraded you so that you can work still hard and obtain higher medal at international". So the jury member himself confessed that he has downgraded me intentionally.

First who gave him the right to downgrade a person instead of honestly judging and giving fair markings? Subsequent all the arguments which he

gave me was very difficult to digest. From his arguments I immediately traced out the brain behind it. If this is the fate of my exhibits to be judged in one minute how one can expect a medal? Same is the case with others. There are so many superb collection worth for higher medals met the same fate like me.

The only lesson I learnt from this exhibition is that if you want a decent award go to International because the members of the jury here are biased minded, partial as well as influenced by unknown people who decides whom to award. Rest is only a false play. I equate this judging with the Sydney Cricket Test in which the entire match was prefixed with empires and match referee and to divert this nasty prefixing find a scapegoat in form of Harbhajan singh to open a new unwarranted debate and change the track. The members of the jury took every clue from it and played their role accordingly. God bless Steve Buckner and INPEX 2008 jury members!

## RAJESH VARMA, Dehradun

I participated in Inpex 08 with a specialized exhibit of Definitive stamps of 8<sup>th</sup>, 9<sup>th</sup>, and special definitive series in five frames. I was shocked to see that it was awarded Silver Bronze medal. I approached a Jury member for his guidance on the shortcomings of my exhibit. In his view I had wasted space by showing Labels used by the Security Printers on the packet of 200 sheets of stamps. I explained that as only for a few months between 2005 and 2006 the definitive stamps were printed on ungummed paper and this fact is stated on the Label that's the reason for showing these while showing varieties printed on ungummed paper. The Juror caught unaware, countered this reasoning by saying that Jury can open the frame and examine the ungummed varieties physically if required.

I then approached another member of the Jury who opined that not only I have wasted space by showing Labels in 8 out of 80 pages of my exhibit, but also by showing complete sheets of stamps. I explained that these sheets were partly imperforated and I aimed at showing part imperfs in different printings. He then said that I should have used arrows to point out part imperfs. I didn't point out to him that by using dark matting the perf and imperf parts of the sheets were clearly visible. He also told that the Labels are not issued to public which I explained to him that it is not so. Finally after a long discussion he conceded that the exhibit should have been awarded at least a Vermeil medal.

Nobody was happy with Jury decision except a few. Several exhibits were downgraded by one, two, or three medal levels by the same Jury from the earlier national exhibitions.

I think we shouldn't exhibit where judging is not just and our exhibits will not get appropriate medals. Jury must update themselves with the times and be well conversant with current trends. They must spend sufficient time by reading the write-up and also comprehending it to adjudge an exhibit which is exhibitor's labor of love of several years. They must not discriminate on the basis of their ignorance or lack of knowledge against any exhibit. The Department of Posts must ensure that Jury on its panel is qualified by testing them annually. Removing unqualified jurors will go a long way in promoting philately in India.
