A recent article in the newspaper caught our attention as it is not every day that a 10-year-old catches the Prime Minister's Office (PMO) and Government of India off-guard.

The article pertained to the query under the Right to Information Act (RTI) regarding 'Father of Nation' status to Mahatma Gandhi, sent by Aishwarya Parashar, a class sixth student from Lucknow in February 2012. The RTI application was sent to the Central Public Information Officer (CPIO) of Prime Minister's office seeking a photocopy of the order through which Mahatma Gandhi was declared as father of the nation.

The PMO forwarded the RTI application to the Ministry of Home Affairs which further sent it to the National Archives of India (NAI).

In its reply Assistant Director of NAI Jayaprabha Ravindranthe, "As per the search among the public records in the NAI there is no specific documents on the information being sought by you; As per the guidelines laid down by the DOPT (Department of Personnel and Training) the duty of the CPIO is only to make available the records for consultation and not undertake any research on behalf of the application. You are therefore most welcome to visit the department to undertake a detailed search among the public records and library material for the desired information."

An amazing state of affairs, makes us wonder how many things are taken as facts without questioning and what actually is the truth.

Centenary of Civil Aviation That Wasn't

On March 14, 2012 India Post released a set of 4 stamps to commemorate 100 years of civil aviation in India.

On October 15, 1982 India Post had issued a stamp earlier to commemorate 50 years of civil aviation in India.

In simple mathematics it is only a gap of 30 years? The question is which one of the 2 dates is wrong or are we looking at different celebrations that have been wrongly been given the name of civil aviation?

If look at the following dates that are documented may be the mystery shall clear: The First Flight in India, also the first flight in Asia, took place on March 10, 1910 at Madras. In the month of December of the same year pioneer flights took place in Patiala, Allahabad, and Calcutta.

The Civil Aviation department of Government of India was formed in 1919 after the end of First world war in 1918 to utilize the spare war planes for civil services as was the case all over the world.

Imperial Airways was formed on March 31, 1924 in UK. Imperial Airways began operation a London – Karachi flight from April 4, 1929.

Commercial aviation in India started on December 28, 1929 when Government of India established Indian State Air Service and connected to the Imperial Airways London - Karcahi flight by Karachi -Delhi flight.

The Indian State Air Service was closed in 1931, and the flight was operated by Delhi Flying Club from 1932 till Imperial Airways took over its operation in 1933.

Aviation Department of Tata Sons, forerunner of Tata Air and eventually of Air India, launched operation with Karachi - Madras flight on October 15, 1932.

From the above documented facts it appears that India Post commemorated 50 years of civil aviation based on the Tata Sons Karachi - Madras flight of 1932. However the first Indian State Air Service Flight was started in December of 1929 and therefore the celebration is technically off the mark by 3 years.

Now the 2012 stamps are commemorating the flight from Karachi to Delhi, as per the brochure acccompanying the stamp issue is stated to have taken place in 1912. This flight did not take place till 1929 thus being off the mark by 17 years.

The Ministry of Civil Avaiation have been celebrating 100 years of Civil Avaiation for one whole year, based on which date? It appears that based on the same date they have proposed the issue of the stamp to India Post which alone dose not desreves the blame.

There are one more set of facts and dates based on official documents by Ministry of Civil Avaiation including the speech of the Minister for Civil Aviation, and Press Information Bureau that need to be taken into consideration:

(1) On 18 February, 1911 the first commercial civil aviation flight took place in India between Allahabad and Naini, a distance of 6 miles when Henri Piquet carried 6500 mails on a Humber

biplane. This is considered to be the world's first airmail service and the beginning of civil aviation in India.

Correct and Well documented version:

Henri Piquet had been flying at Allahabad from December 11, 1910 onwards without carrying mails. His colleague Davies had also flown a day before in Bleriot on December 10, 1910.

(2) In December 1912, the Indian State Air Services in collaboration with UK based Imperial Airways introduced the London -Karachi - Delhi flight, the first International flight to and from India.

Correct and Well documented version:

Commercial aviation in India started on December 28, 1929 when Government of India established Indian State Air Service and connected to the Imperial Airways London - Karcahi flight. Imperial Airways it self was formed only in 1924

(3) In 1915 Tata Sons Ltd started regular air mail services between Karachi and Madras and on January 24, 1920 Royal Airforce started regular airmail services between Karachi and Bombay.

Correct and Well documented version:

Aviation Department of Tata Sons, forerunner of Tata Air and eventually of Air India, launched operation with Karachi - Madras flight on October 15, 1932.

There are many more such anomalies that appear in the documentation of the Ministry of Civil Aviation.

The information quoted above and offcially issued by Government of India Press Information Bureau is either an attempt to rewrite the history or is proof that no one in the Government of India knows the history and worse still no one cares to even check their facts before publishing and speneding millions of public money.

Someone needs to point out to the Ministry of Civil Avaiation, and Press Information Bureau that advent of airmail and civil avaition is not the same thing.

The pioneer flights were taking place from the March 1910, one needs to now look at what is being celebrated? A first ever flight, a flight with passengers, a flight with letters, a cargo flight, a commercial flight as all dates are different. How does the Government define Civil Aviation? The date of the celebration should match that.

The official documents by Ministry of Civil Avaiation, Press Information Bureau, and India Post, that have not clarified the above and have been repeated a large number of times over the internet seem to have become the new truth for unsuspecting readers worldwide.

And in the eyes of the researchers and historians who know the true facts, the Government of India becomes a perpertrator of disinformation.

It appears an RTI to Ministry of Civil Avaiation, Press Information Bureau, and India Post would be in order to not only to ascertain facts but also to fix responsibility.

Australia 2013 World Stamp Exhibition

Australian Philatelic Federation is organizing 'Australia 2013' World Stamp Exhibition from May 10 to 15, 2013 at Melbourne, Australia. Besides all regular FIP classes, Australia 13 will also have Open Philately Class and Promotional Class for 50 Years ModernTraditional Philately. The participation fees are AUD 90, equivalent to Indian Rupees 4,750 approximately, per frame or per exhibit in the Literature class. The fees for One Frame exhibits are AUD 150 or over Rs 8,000. These are highest ever fees for participation in a international philatelic exhibition.

Costas Chazapis, Editor of Philoteliea, in Editorial of the January/February 2012 issue, describes Australia 2013 as a 'bad precedent'. Chazapis's criticism concerns the exorbitant raise in the fees that exhibitors have to pay for their participation in the exhibition. He speaks of a 'burden' for exhibitors and he regards the higher fees as 'discouraging'.

Article of the Month: March 2012

First Day of Issue Postmarks of Stamp Centenary Issue

India Post celebrated the centenary of the India postage stamps on a grand scale all over the country. A set of 4 stamps in the denomiation of 1, 2, 4 and 14 annas commemorating the event were issued on October 1, 1954. Also issued on this day was a set of 7 commeorative postal stationery items – 9 pies Postcard, 1½ annas Inland Letter Card, 2 annas Embossed envelope in commercial size, 2 annas square Stamped envelope, 8 annas Aerogramme, 9½ annas Registration envelope, and 14 annas Airmail envelope. The Airmail envelope sold for 14½ annas contained a sheet of blue letter paper with inscription 'India Postage Stamp Centenary 1854 – 1954' in English printed on top. Special Letter Pads containg 16 sheets of white paper with inscription 'India Postage Stamp Centenary 1854 – 1954' in Hindi printed on top were also issued at 4 annas per pad.

A multicolor First Day Cover priced at 1 anna was released for this issue. However no brochure was issued on this occasion.

A special First Day of Issue pictorial postmark was provided at 34 post offices across India for this issue. Usually at that time the First Day of Issue postmark was provided at the philatelic bureaus that were 10 in all. Thus for this issue the First Day of Issue postmark was provided at additional 24 locations. The postmark was inscribed 'India Postage Stamp Centenary' and depicted a postal runner and an aircraft.

The First Day of Issue postmark with inscription 'International Philatelic & Postal Exhibition' and with same design as that with the inscription 'India Postage Stamp Centenary', was provided at New Delhi as well as at Calcutta.

In addition the INDIPEX P O at the India International Philatelic Exhibition at New Delhi also serviced the First Day Covers with its date postmark.

All these postmarks were provided in both the languages English and in Hindi. Thus there were 2 postmarks for each location, one in each language. A complete collection of the First Day of Issue postmark of this issue will have 74 different postmarks.

India International Philatelic Exhibition was held at New Delhi. It was the first large scale exhibition in this part of the world with participation from 70 countries. This exhibition was originally scheduled from October 1 to 15 but was extended to October 31, 1954. International Postal Exhibition was also held at New Delhi from October 1 to 31, 1954.
