INDIA POST PROTECTS TURF FROM FOREIGN COMPANIES

India Post has come in the way of DHL's ambitions in India. In a spirited attempt to protect its market share in the lucrative market for parcels and express mails, India Post has opposed the latest proposal by the Netherlands-based DHL Worldwide Express BV (DHL BV) to acquire a further 45.56% equity capital of DHL India from its present shareholders.

India Post has argued that the transfer of shares will allow Deutsche Post, which recently bought over DHL Worldwide, to enter India and "take away the best portion of the market without the obligations to serve the interiors of the country". Interestingly, this is the first time the government has sought India Post's views on a foreign investment proposal by any foreign parcel/express logistics company.

DHL BV has proposed to acquire 13,04,500 fully, paid-up equity shares of Rs.10 each at a price equivalent to Rs.805.99 per equity share, involving a total forex inflow of about Rs.1.05 billion.

According to DHL, it is engaged in the business of international air express services and therefore, falls under the automatic approval route, permitting up to 100% foreign holding.

DHL BV first got approval in March 2002 to purchase 14,84,720 equity shares of Rs.10 each, representing 51.9% equity capital of DHL Worldwide

Express (India). Interestingly, India Post was not a party to the government's consent that time.

India Post has argued that the earlier approval to transfer shares was accorded before Deutsche Post took over DHL.

Therefore a distinction should be drawn between the two applications. "DHL is now the parcel/express division of Deutsche Post with its headquarters in Germany and known as Deutsche Post Euro Express and not the name stated in the communication mentioned above," says India Post in a its objection letter.

It says that the increasing volumes of shipments being transported by DHL India require substantial infrastructural investment to maintain its competitive capabilities in India. However, DHL India's current shareholders are unwilling to support any further investments.

DHL India was incorporated in April 2001 with an authorized share capital of Rs.0.5 billion. The company's present paid-up capital is around Rs.286.5 million consisting of 28,63,470 equity shares of Rs.10 each. DHL India is engaged in the business of international air-express services and has an alliance with local courier major, Blue Dart Express, to handle the domestic section of the parcel pick-up and distribution business.

FAKE REVENUE STAMP RACKET BUSTED IN MUMBAI

The police busted a fake revenue stamp racket and arrested two persons in this connection. Fake stamps valued over Rs.0.65 million were seized from Suresh Pitale and Chedilal Vishwakarma.

Police said they were not connected with the Abdul Karim Telgi gang which is involved in the multi-billion fake stamp scam. Acting on a tip-off that bogus stamps were being sold in Andheri area, the police laid a trap and arrested Pitale and stamps worth Rs.5,000 were found on him.

A search of his house in Kandivli yielded stamps worth Rs.0.645 million. Later police arrested his accomplice Vishwakarma. Senior inspectors Anand Bhilare said the accused were arrested in a similar case of bogus stamps eight years ago in Alibaug and are currently out on bail in that case.

The police are on the look out for six others in the case. "We are still to ascertain who manufactured and supplied the fake stamps to the accused," Mr Bhilare said.

FAKE STAMP SCAM UPDATES

Judicial magistrate first class (JMFC) M N Bondre on August 6, 2003 remanded Abdul Rashid Sikandar Saheb Kulkarni alias Rafique Kulkarni, lawyer of Abdul Karim Telgi - alleged kingpin in the fake stamp racket - to police custody till August 16, 2003.

The 49th accused to be booked under the Maharashtra Control of Organised Crime Act (MCOCA) in the multi-billion scam was produced before the court by the Pune police's special investigation team (SIT).

Demanding 30 days' police custody for Kulkarni, special public prosecutor Raja Thakare said the SIT had arrested Kulkarni only after gathering sufficient evidence of his involvement in the racket. It had come to a point when, without custodial interrogation, further investigation could not proceed.

Thakare revealed that on January 10, 2003, when the police raided the kingpin's flat at Colaba, Mumbai, they recovered Kulkarni's suitcase, bearing Rs.5 million in cash. Thakare said the SIT summoned Kulkarni in January 2003, but he did not respond. "The SIT could have arrested him then but did not," he said.

Thakare, however, admitted Kulkarni had appeared before the SIT on May 25, 2003. Thakare further revealed that Kulkarni's explicit role in the scam came to light only after the arrest of suspended assistant police inspector Dilip Kamat. Thereafter, Kulkarni's residence was searched and a cassette tape recorder found.

The recorder had been fitted in a car which had earlier been used in the murder of a Telgi associate. Kulkarni's role in that murder needs further investigation, he submitted. Further augmenting his case, Thakare claimed two witnesses had told the SIT that Kulkarni had earned millions of rupees by transgressing all (professional) norms and assisting the crime syndicate.

"He received Rs.3.5 million on two different occasions when Telgi was in the custody of the Pune police," Thakare alleged. The SIT is yet to recover the amount from Kulkarni. Mounting a strong counter-attack, defense counsel Shrikant Shivde alleged that Kulkarni had been arrested without proper understanding of the law.

The SIT holds a grudge against Kulkarni, Shivde said, for he has proved an obstacle in their path since the beginning. "I agree, he had filed the vakalatnama on behalf of Telgi and other accused. This is what is held by the police against him." Shivde pointed out that Kulkarni has never been named a suspect.

"A lawyer going to his client's flat is not an offence," he argued. The defense counsel refuted reports that Kulkarni had acted as an agent for the police and the scam accused. He reiterated the allegation that the SIT had threatened Kulkarni when he refused to reveal any police officers involved in the scam. "Kulkarni is merely a scapegoat in the fight between two lobbies of police officers," Shivde said. He said the murder charges (related to the car tape recorder mentioned above) were beyond the scope of the SIT, which is in charge of the fiscal scam.

Shivde claimed Kulkarni was burdened by heavy loans and did not have millions of rupees as alleged by the prosecution. He, therefore, requested the court to grant magisterial custody and insisted the SIT

may interrogate Kulkarni only from 10 am to 5 pm. He expressed the fear that Kulkarni may be tortured during nightly interrogations.

Pandemonium prevailed in the Legislative Assembly of Karnataka state on August 8, 2003 with Bhartiya Janta Party (BJP) members demanding the resignation of small-scale industries minister R Roshan Baig following a statement from retired police officer H T Sangliana that the former's brother had links with fake stamp kingpin Abdul Kareem Lala Telgi.

Sangliana had stated in a section of the press that Baig's presence in the cabinet resulted in the state government being hesitant of referring the racket to the Central Bureau of Investigation (CBI) for inquiry.

The issue figured in both Houses of the legislature. In the Legislative Council, M R Tanga (BJP) said: "He should be dropped from the cabinet or he should prove his innocence by filing a defamation case against Sangliana and the newspaper." Chairman B L Shankar directed the government to speak to the reporter and to Sangliana, to verify his "sweeping remarks' on the issue." Sangliana has accused several politicians and police officers of having links with Lala. Nothing prevented him from revealing this when in service," he pointed out.

In the Legislative Assembly, opposition leader Jagadish Shettar sought to move an adjournment motion, while members shouted slogans and tore up books. "Why are you not giving the investigation to CBI? You are scared because a minister's brother is involved," Shettar stated. Home minister Mallikarjun M Kharge said discussions in the House would hamper the scam investigation. "Our efforts to book the culprits will go waste. We are not hiding or protecting anyone," he maintained. Heated exchanges ensued between ruling and opposition benches. AIPJD floor leader B Somasekhar accused speaker M V Venkatappa of being "unable to control the situation," before the House was adjourned.

After an hour-and-a-half of discussions in the Speaker's chamber, it reassembled, only to see further disruption. "Political interference has tied the hands of Additional Director General of Police R Srikumar's stamp investigation team. Why have you not interrogated the minister's brother?" BJP members shouted.

Kharge said of the ten cases under investigation, charge sheets have been filed in seven. "The Centre asked our opinion on giving the case to CBI. We said our investigation is at an advanced stage, there is no need for CBI." CBI seized Lala's passport on July 30, 1998. "They have full powers to investigate. There is no political pressure. The opposition is just trying to gain political mileage," Kharge maintained. This sparked off further furor. BJP legislators even prevented the Speaker from making a statement. Amidst the din, the House passed four bills and withdrew the Karnataka Lok Ayukta (Amendment) Bill, before adjourning sine dine.

BNPA SILVER JUBILEE PROGRAM CONCLUDES

The week-long silver jubilee celebration and philatelic exhibition of Bangladesh National Philatelic Association (BNPA) ended on July 27, 2003.

Syed Margub Murshed, chairman of Bangladesh Telecommunication Regulatory Commission, attended the closing ceremony as chief guest, held at the Dhaka General Post Office (GPO). BNPA President Prof. Kazi Shariful Alam presided.

Margub Murshed gave away prizes among four winners from the junior group who exhibited their stamps. A total of 17 students of different schools took part in the exhibition.

Certificates were also given to the senior participants who are renowned philatelists. Thirty-four philatelists exhibited their best collections.

Prof. Shariful Alam said the association, formed in 1978, has organized 20 philatelic exhibitions in the last 25 years. It also holds auction of stamps every month.

The association organized a philatelic exhibition, workshop, reception for renowned philatelist Abdus Salam, museum tour, auction and quiz program to mark its silver jubilee.

Over 20 thousand stamps were put on display in the exhibition.

RESEARCH NOTES

GODAVARI PUSHKARMAS MEGHDOOT POST CARD

With a view to assist a thematic philatelist looking for the story behind the issue, we provide here the story behind the Meghdoot Post Card issued on July 30, 2003 publicizing "Godavari Pushkarmas 2003".

Pushkaram is a 12-day festival celebrated in reverence of the holy rivers once in 12 years. This period for a river is regarded as a pious occasion purging people of all evils and a dip in the river any time of the year is considered holy and cleansing; an invisible power is believed to flow through the river during Pushkaram.

This year the Godavari Pushkaram festival is being celebrated from July 30 to August 12, 2003. Rajahmundry is the traditional site however 8 additional sites are opened this year.

To boost tourism, the Andhra Pradesh state government has made this the event of the year. Publicity of the event six months prior to the festivities seems to have helped; the administration expects at least 35 million visitors.

#### MAIL RAIL FOR SALE

London's secret under-ground railway - the postal system that carries parcels and letters across the city - is to be put up for sale. Royal Mail said it was in discussions with several organizations about a "wide range of alternative options" for the 75-year-old Mail Rail network that would keep it as a "going concern".

James Taylor, of Royal Mail, said: "It is too early to even speculate on what we can do with it." Royal Mail, which made a £600m loss last year and has a £4.6bn pensions black hole, says that operating the miniature railway costs four times as much as using the roads. Taylor said: "It doesn't serve the purpose it was originally created for. The reason is that the locations of the mail centers have moved."

But Andrew Pelling, chairman of the London assembly's public service committee and author of a report this week into the future of Mail Rail, criticized what he called "short-term decision making". "It is such a shame to see an asset like this going for mothballing ... Other capital cities would love to have this type of facility and use it actively." He suggested the network could be used to transport goods and valuable items such as jewellery to department stores, freight to airports, and alcohol to the West End. "London is now more a city of drinkers than writers of letters," said Pelling.

The Mail Rail network runs for 23 miles between Whitechapel and Paddington. At its peak, it served nine stations and shifted 7m bags of letters but now it is down to 3.4m bags a week, with just three stations still open: Paddington, Mount Pleasant and Whitechapel.

The company said the 76 workers would be offered retraining or voluntary redundancy but there would be no compulsory redundancies. A few staff would be retained to maintain the railway.

Mail Rail and its driverless miniature trains, each 8.4m long and 1.2m high, were conceived in the 19th century to combat congestion on London roads.
