WELCOME TO INPEX 08

It is now clear that the sole purpose of organizing INPEX 08 is to further the vested interests of a few habitual violators of the laws of

land. These persons have managed to convince the India Post to fund the show where rules have been modified against India Post's own interests such as removing 'Modern Philately' class.

Till the last minute, committee members and jurors were being added and removed. If one was not selected he brought in political or bureaucratic pressure to get in.

The allotment has been arbitrary and rules were not applied equally to all. Hundreds of qualified exhibits were not accepted and scores of unqualified exhibits were accepted. Entries received a month after the last date was accepted while those who submitted in time were not. Several of the accepted exhibits contain false information on their application form. Many who had applied for One Frame Class were asked to extend their exhibit to 2 Frames! Those who threatened the INPEX Secretariat were accommodated against the rules and those who didn't were not.

Welcome to national philatelic exhibition at Chennai from January 2 to 6, 2008 and experience the chaotic world of Indian philately in transition.

NEW STAMP RELEASED

SNOWS BASILICA

India Post released a commemorative stamp on $425^{\rm th}$ anniversary of Snows Basilica on December 25, 2007 in the denomination Rs 5.

Situated in Tuticorin the church was built during 1582 dedicated to St. Peter and later Jesuits consecrated to Our Lady of Snows. In 1542 St. Francis Xavier visited the shrine to catechize the paravars, the indigenous people of the Pearl Fishery Coast.

In 1982, when the Church of Our Lady of Snows celebrated the 400th anniversary, Pope John Paul II raised it to the status of Basilica.

The Basilica is also known for a golden car, which is used to carry the miraculous statue of Our Lady of Snows around the town during her feast day. The Golden Car was first taken in procession on 2nd February 1806 and then onwards 5th August of every year. A Big star rests over the royal crown on the top of the car, signifying the name of Our Lady as the Star of the Sea (Stella Maris).

Kamleshwar Singh designed the Stamp. Alka Sharma designed the First Day Cover and the pictorial first day postmark. Brochure containing Kamleshwar Singh pictorial first day postmark. Brochure containing write-up and technical data was issued on the occasion. The First Day Cover and the Brochure are priced at Rs 2 each. Security Printing Press, Hyderabad printed the stamps by wet offset in the quantity 0.4 million.

WILSON COLLEGE FIRST DAY COVER

The First Day Cover of Wilson College commemorative stamp issued on December 11, 2007 carried incorrect inscription "150 Years" instead of "175 Years". However this mistake was detected and all philatelic bureaus were instructed to sell the covers after correcting the error.

In some places it was corrected manually and at some by paste-ups. However some places it was sold as it is.

RIGHT TO INFORMATION

The Right to Information Act came in to force on October 12, 2005. This law empowers the citizens to ask for information that is any material in any form including records, documents, memos, e-mails, opinions,

advices, press releases, circulars, orders, logbooks, contracts, reports, papers, samples, models, data material held in any electronic form and information relating to any private body which can be accessed by a public authority under any other law for the time being in force. Reason/s for seeking information are not required to be given. The public authorities are obliged to provide the information within 30 days.

There is no form to be filled, however please ensure the following information is included in your request:

Your Name, and your contact details including complete postal address, telephone numbers and email address (if any)

How you would like to receive this information, for example by post

Nature and details of the information requested

Date on which application is being submitted

Also please attach a proof of payment of application fee.

The fee is Rs 10 per request and can be deposited in any post office under the RTI Act 2005 Rules in UCR and receipt of the same should be attached with the request.

There is also a charge for Rs 2 per page of the information provided. It is a good idea to mention in the request that you will pay these additional charges on demand.

The exhibitors participating in National level philatelic exhibitions have to pay good amount of entry fee for participation. The expenses of dispatching the exhibits to the exhibition are born by the exhibitor. As the exhibitions are organised by the Postal department it can do a favour to philatelists by sending the exhibits from G.P.O. of capital cities to the exhibition destination. For this during the exhibition, collection counter for exhibits can be opened for a limited period of time by the department. As we are aware that the exhibitors have to spend a good amount of money to send their exhibits by speed post. If they send by other services which cost less normally reach quite late. This service can also be provided at state level exhibitions at certain important head post offices . The department can easily provide this service. This facility will be very helpful for the philatelists. There is no doubt that Deptt. of posts earns a good amount of money through philatelists who spend a lot of amount on purchasing Indian stamps and of course during philatelic exhibitions.
