India Today the popular weekly news magazine in its issue dated August 18, 2008 did a two page story 'Stamp of a scam' by Mihir Srivastava. It is also available online at the following link http://indiatoday.digitaltoday.in/index.php?option=com_content&Itemid=1&task=view&id=12729§ionid=36&issueid=66&page=archieve. It is about stamps being available in the market months before they are officially released by India Post.

We have regularly been reporting events of this nature for years and have reported the premature stamps mentioned in India Today about six months ago in February 2008.

However we do wish that a magazine of India Today's stature to have balanced coverage which this story unfortunately does not have. It is possible that 10 persons are selling premature issues online and possibly 90 more are selling them offline; then why signal out only one person? Why not do some more investigation? Why not list more names of persons who are selling these stamps?

We also believe it is a good journalistic practice to talk to those you write about. In this case Mihir Srivastava didn't even speak to Vinod Sabharwal to get his version or explanation. We find this strange. The slant of the story appears to be as if Sabharwal is the only person distributing stamps months before their release and it seems as if he is the only one who has managed a steady supply from the philatelic bureau New Delhi.

We consider premature sale of stamps a serious offense. The stamps which come out of postal treasuries before the issue date are sold by mistake sometimes by some post office usually due to the rescheduling of the issue information not reaching on time and this use to happen once in a while. However the regular availability of almost all issues in quantity in recent times indicates the involvement of postal employees. It is a clear case of embezzlement in the postal treasury. What steps, if any, have been taken by India Post to stop this ongoing pilferage is not known?

We firmly believe that inaction of the postal officers on the large scale premature supply of Guru Granth Sahib in 2005 emboldened the postal employees, stamp dealers, philatelists, and investors. Even a catalog publisher in India has listed this premature issue with full catalog status as any other regular issue. India Post did issue orders that this particular issue is not valid for postage, cannot be exhibited in philatelic exhibitions, and will be seized by India Post, however this was a mere formality. Strangely these orders were confidential and were not communicated to philatelic community!

First of all to deal with the problem of premature stamps it is required that the officers responsible in India Post should relearn to accept responsibility for their actions or inactions and any orders issued to deal with the premature issues should be given maximum possible publicity as well as strictly adhered to.

PROJECT ARROW BY INDIA POST

India Post has launched a series of fully upgraded and completely new look Post Offices in the services of the rural people. Called "Project Arrow", the launch aims to re-vitalize the post office network and enable it to play a larger role in socio-economic transformation of the country. These new age Post Offices are meant to serve as a window to the world for the common man by focusing on their needs. The Minister of Communications & Information Technology, A Raja inaugurated Project Arrow in Post Offices at Perambalur and Geetha Mahal, Kallankurichi Road, Ariyalur in Tamil Nadu. The Minister of State for Communications & IT, Jyotiraditya M Scindia inaugurated the Project at Murar Head Post Office (Gwalior), Morena, Shivpuri, Guna and Ashok Nagar in Madhya Pradesh.

Under the project, India Post has identified 50 post offices in Andhra Pradesh, Jharkhand, Maharashtra, North East, Madhya Pradesh, Orissa, Rajasthan, Tamil Nadu, Uttar Pradesh and Uttarakhand covering 10 Postal Circles. By the end of the current year, 500 such Post Offices will get operational in the country. Strict adherence to the timelines is part of the strategy.

These post offices are being given a thorough make over both in terms of "physical look and feel" and upgrading service delivery through IT enabled procedures. Identity branding including a new logo and a new slogan, designing of exteriors and interiors, upgradation of computer hardware and software, improvement in delivery of services and upgradation in connectivity are the main features of the Project Arrow. The post office in rural areas will henceforth be a single window facility for banking, money remittance, transmission and delivery of information. Besides providing traditional services in a modern, more efficient and technology based mode, the post offices will also form an indispensable part of all social and civic initiatives such as National Rural Employment Guarantee Scheme and National Old Age Pension Scheme. The stress is on creating a conducive and friendly work environment for both staff and customers.

Project Arrow has twin objectives: to transform India Posts into a vibrant and responsive organization and to make a visible and positive difference in postal operations to benefit the customers. Nearly 89% of the network of India Post is in rural areas. Project Arrow is expected to bring the rural populace in direct communication with the outside world and bring benefits of development to their doorsteps. The Project is being seen as a significant step towards realization of India Post's motto - "Dak Seva-Jan Seva" (postal service - people's service).

Project Arrow will provide the necessary impetus to other post offices to ensure that the formidable network of the Department of Posts becomes a seamless technology driven India-wide network. A Steering Committee and a Core Team have been put in place in the Ministry of Communications and IT to monitor implementation of the Project at all stages.

PIN CODE DIRECTORY 2008

The India Post PIN Code Directory 2008 CD was released on July 25, 2008. The Directory maps over 150,000 post offices in India to PIN Codes and provides useful information about the post offices.

The Features of this product include, PIN Code database downloadable in Excel (csv) format. It would be possible to integrate the database with mailing lists of organizations, so that PIN codes can be added or corrected in the addresses; Search, View and Print options for PIN Codes of states and districts including individual PIN Codes; Printing of selected range of PIN Code information; and Free PDF version of the book, 'The India Post Ready Reckoner'.

The package can be installed in Desktop (Single System) or Server Client mode. All prerequisites for installation are provided in the CD.

VIEWS & OPINIONS

INDIA POST & RIGHT TO INFORMATION
Subhash Chandra Agrawal of Delhi is the Guinness Record Holder for most letters in newspapers. He has written score of letters on postal and philatelic matters as well. Here we reproduce his recent submission regarding his petition to the Information Commissioner under Right To Information Act documenting his experience seeking information from the Philately Division of India Post.

Re Petition Number CIC/MA/C/2008/00276; Submissions in response to first hearing held on 06.08.2008

Respected Sir

Kindly refer to reply number 43-1/2008-Phil dated 05.08.2008 filed by Deputy Director General (Philately) while seeking adjournment on behalf of Department of Posts on my petition Number CIC/MA/C/2008/00276 earlier fixed for hearing on 06.08.2008 (12.10 pm).

- 1. It is wrong to suggest that a reply dated 04.02.2008 from Department of Posts was in response to any of my RTI petitions dated 17.12.2007 and 28.02.2008 now before the Honourable Commission under section 18 of RTI Act. In fact, reply dated 04.02.2008 was in response to my other petition also of 17.12.2007. Though even this reply was also late, yet the petitioner did not cover that very petition also dated 17.12.2007 for which a late reply dated 04.02.2008 has been mentioned by the Respondent.
- 2. Respondents have for first time in their letter dated 06.06.2008 responded to my query raised in my RTI petition dated 17.12.2007 about multi-denomination stamp-sheets requiring reasons for having stamps of more than one denomination in one stamp-sheet when users of different denominations are different, and about proportion of such stamp-sheets lying unsold. Reply though inconclusive was late by more than five months. Respondents have failed to give reasons for issuing multi-denomination stamp-sheets when users of different denominations were different, and it was admitted that such multi-denomination stamp-sheets were lying unsold with the Department. Directions may kindly be given to respondents to provide reasons for a practice which is contrary to interest of the Department and users of postal services.
- 3. Respondents replied to my RTI petition dated 28.02.2008 about violation of rule number 72(4) at chapter VIII 'Miscellaneous' of Handbook on Philately issued by Department of Posts, in issuing of commemorative stamp in honour of late Shri Murasoli Maran in regime of his son Shri Dayanidhi Maran as Union Communication Minister when the rule was not to issue any such stamp before ten years after death of a personality exception being heads of state. It is shocking to note that the learned Appellate Authority at Department of Posts in its order

dated 06.06.2008 did not take it as violation of rule! It is of significance that list of 96 such cases of commemorative stamps issued before ten years of death of a personality, as provided by the CPIO, mentions the word 'exception' on such issuance of commemorative stamps for heads of nation and also heads of government and father of nation even though rules allowed such exemption only for heads of state. A copy of TOI report 13.06.2008 on the matter is enclosed for kind ready reference. It may be mentioned that India is a democratic republic rather than a monarchy-ruled state, and a Union Minister cannot have discretionary power to violate rules framed for the Department concerning his Ministry. I appeal that information regarding violation of rules by Department of Posts should be admitted and made public.

It is prayed accordingly.
