## Jhingans Jottings

Hi,

In a written reply in the parliament on May 16, 2012, the Minister of State for Communications & Information Technology virtually gave the New Rules for Issue of Commemorative Postage Stamps. Read it in this issue and send us your comments.

India Post is still to formulate its National Postal Policy and the draft document circulated does not even contain the words stamps or philately. The stake holders of Indian philately should be worried. Let us all join hands to ensure India Post formulates a National Philatelic Policy incorporating good philatelic practices.

The Ministers have been taken for a ride by bureaucrats on several occasions. One can laugh or feel ashamed when the Ministers are reading speeches prepared by the postal officers that have serious errors of facts and figures. The most amazing part is no one is ever held responsible for a philatelic action however incorrect it may have been as if there is an immunity to punishment for philatelic misdemeanors.

Today most of the philatelic activities in India are carried out on personal understanding whether correct or incorrect, or even whims and fancies of postal officers in absence of a clear policy with effective deterrents. Thus there is an urgent need for inclusion of punishment and penalty clauses in the India Post's philatelic rules and regulations.

### **Fakes of Indian Rarities**

Although we have been hearing about fakes of Mahatma Gandhi 1948 Rs 10 for over a year now, no one was able to show us one. We now have seen one listed for sale on eBay and offered as a Forgery. It looks dangerously good in the image, especially the large one. The problem is not in selling a forgery as a forgery but there is always a risk that the new owner may pass it on further as genuine. If we can lay our hands on this forgery, we may be able to document its characteristics.

India 1992 Birds of Prey Error Re 1 instead of Rs 2 was offered on Delcampe in March 2012 in the quantity of, believe it or not, 5 pieces including a pair. One catalog published in India lists that only 4 pieces were found within Annual Collector been told that these were fakes but we have no ways to ascertain the facts for ourselves.

#### **Karpoor Chandra Kulish**

India Post released a stamp in the denomination of Rs 5 to commemorate Karpoor Chandra Kulish, an outstanding journalist, on May 16, 2012. Kulish also was a poet, a scholar of Vedas, a thinker, and philosopher who founded well known Hindi newspaper Rajasthan Patrika.

Kamleshwar Singh designed the stamp, and the First Day Cover. Alka Sharma designed the pictorial First Day of Issue postmark. The First Day Cover and the Brochure are priced at Rs 2 each. Security Printing Press, Hyderabad printed 350,000 stamps by wet offset process.

### e-Postal order

V Narayanasamy, Minister of State in the Ministry of Personnel, Public Grievances & Pensions, and Prime Minister's Office, informed the Parliament on May 10, 2012 that Government of India has 'in-principle' agreed to start sale of Indian Postal Orders through internet on payment in foreign currency to facilitate Indians living abroad to use the Right to Information Act (RTI) effectively.

The Right to Information (Regulation of Fee & Cost) Rules, 2005 provides that a request for obtaining information should be accompanied by an application fee of Rs 10 by way of cash against proper receipt or by demand draft or bankers cheque or Indian Postal Order payable to the Accounts Officer

#### **Issue of Commemorative Postage Stamps**

Sachin Pilot, Minister of State for Communications & Information Technology, gave the following information in a written reply in the Lok Sabha on May 16, 2012:

The commemorative postage stamps issued by the Department of Posts are determined based on the following rules:

1. Commemorative postage stamps will be issued on subjects that have a national or international stature or have made national/international contribution or impact or reflect national/international areas of concern.
2. The Annual Issue Programme shall reflect regional, cultural and ethnic balance.
3. Stamps on a particular subject shall issue only once, except thematic such as wild life, environment, transport, flora fauna etc. or regular issues like Children's Day, Season Greetings and sets on heritage, nature, culture, art, architecture etc.
4. Stamps shall be issued only on the apex institutions, not on branches of any institution or organization.
5. There shall be not over 50 issues (maximum 100 stamps) of commemorative stamps per annum.
6. Stamps on personalities shall not exceed 10% of the Annual Issue Programme.
7. The Union Minister incharge of the Ministry of Communications & IT may approve 5% of the Annual Issue Programme.
8. The date of issue shall be fixed by the Philately Division keeping in view the significant dates relating to the subject and the availability of slots in the printing schedule.
9. Dates of issue once fixed shall not be changed. A proponent may hold a presentation function on any day on or after the date of issue.

10. Proposals may be sent by any citizen of India.
11. Proposals should be sent at least two years in advance for consideration by the Philatelic Advisory Committee (PAC) and approval by the competent authority.
12. Proposals must be submitted in the format available on [indiapost.gov.in](http://indiapost.gov.in).
13. Proposals will be considered and recommended/not recommended by the PAC. They will not be carried forward for the next PAC meeting.
14. Proponents shall follow the protocol for release functions.
15. The Department of Posts will decide the subject matters, prohibited subjects renewal of philatelic products, procedure for proposal consideration and issue/release of a stamp, period of sale of commemorative/special stamps and for definitive stamps and postal stationery. It will also determine issue policy, withdrawal policy and archival policy.
16. The denominations of postage stamps shall be in consonance with domestic and international postal tariffs.
17. The personalities on whom commemorative stamp may be issued should be of national or international importance. The occasion to be commemorated must be the birth centenary or 10th / 25th /50th /100th death anniversary. No stamp will be issued sooner than ten years after an individual's death. A commemorative stamp shall be issued in honour of the head of State on his/her first death anniversary.
18. A stamp on an institution, building, monument etc. may be issued on its centenary/125th anniversary/ 150th anniversary etc. The building, institution to be so honoured must be Heritage site of national/international importance or site recognized by ASI of national/international importance. Building of regional importance may be commemorated with issue of special cover with special cancellation.
19. At least 25% of the stamps issued in a year will be on popular themes like flora, fauna, culture, heritage etc.
20. Proponents for the stamps relating to institutions/events/large organisations are required to make a mandatory purchase of a minimum number of 1 lakh stamps and the requisite philatelic ancillaries.

### **Largest Collection of Stamps featuring Birds**

Daniel Monteiro, an Office Assistant at the St Mary's Syrian (SMS) College at Brahmavar in Udupi district, member of Dakshin Kannada Philatelic and Numismatic Association, Mangalore, has 4,911 stamps on birds from 263 countries - setting the new world record for the Largest collection of stamps featuring birds, according to the World Records Academy

Monteiro attempted for the new world record by organising a philatelic exhibition titled "Birdpex-2011" in Brahmavar in December 2011.

The Guinness world record is held by Paul-Erwin Oswald of Germany, who had a collection of 2,166 stamps on birds from 126 countries as of March 14, 2011.

Monteiro started collecting stamps at the age of 11 when his teacher encouraged him to develop a hobby. He began by collecting stamps of all types and went on to specialise in water birds. Later, he took to ornithological studies, bird watching and environment protection. He won numerous awards, including 10 international-level awards from Belgium, Austria, South Africa, Singapore, Hong Kong, Bangkok, Korea, Indonesia and China, 21 national-level and 13 State-level and from 31 prestigious institutions in Karnataka.

Monteiro's another achievement was his entry into the Limca Book of Records, a due recognition for his rare collection of stamps on ducks, and also three records for largest collection of stamps on ducks, largest collection of stamps on birds, and one-man largest exhibition "Birdpex-2011".

Monteiro, on his own initiative, organised 163 exhibitions on philately and 31 workshops on environment and philately, and has also actively involved himself in creating awareness about wildlife and environment protection.

### **Stamp of the Past: Indian Heritage in Philately**

The Archaeological Survey of India has completed 150 years of its existence as the Nation's premier organization for archaeological research and protection of the cultural heritage. As a significant component of the year-long celebrations, an exhibition titled "Stamp of the past: Indian Heritage in Philately" in collaboration with Department of Posts besides contribution from some philatelists will be mounted and inaugurated on the occasion of International Museum Day on 18th May, 2012 at Red Fort. The International Council of Museums (ICOM) observes International Museum Day to spread public awareness of the role of museums in the development of society. The original stamps, first day cover, mini sheets and other philatelic objects provided by the Department of Posts and material provided philatelists will be displayed in the exhibition.

The Postage stamp is a mode of commemorating, celebrating and promoting National Heritage and Events. It plays a great role as an ambassador, a brand image of postal administration, a statement of sovereignty of a nation and also acts as significant carrier of the public message reaching the entire national as well as its international diaspora. Postal stamps mirror the rich and many-splendoured aspects of this land and were used to highlight the country's wealth of cultural and natural heritage. Many beautiful stamps were issued in thematic sets on arts, architecture, crafts and maritime heritage. Besides above, great leaders of nation and personalities who have made immense contributions in areas like painting, literature, science, music, etc. have also been honored.

The Department of Posts has frequently released stamps of various denominations on different occasions illustrating monuments or heritage making them popular among the masses, creating consciousness about national legacy and stirring interest for their protection and preservation in the minds of people. Thus it serves the purpose of arousing awareness about cultural properties which is one of the prime objectives of Archaeological Survey of India.

The exhibition aims to accomplish the task of creating a sense of pride in our cultural legacy and imbuing the citizens of India with a heightened sense of responsibility about their contribution to the protection of our heritage.

The exhibition will be on show from May 18 to July 17, 2012 (except Monday) from 9 AM to 5 PM at Red Fort. Bilingual brochures in Hindi and English on the exhibits have also been published.
